WHEREAS on February 24, 2021, the City Council of the City of Saint Paul adopted Council File No. AR 21-2 to ratify the assessment for Securing and/or Emergency Boarding services during September 2020. (File No. J2104B, Assessment No. 218103); and

WHEREAS, the property at 969 Charles Avenue, being described as: Weed & Lawrence's Addition to Saint Paul, Minn. E 1/2 of Lot 3 and All of Lot 2 Blk 3, with the property identification number 35-29-23-24-0154 was assessed an amount of \$454; and
