**Stated Reason for Appeal (if given):** I purchased this house on February 1st, 2021, therefore I did not own the house during the period of the delinquent garbage bill. I recently had a fire at my house of 1957 Berkeley Ave and was not able to get access to the house until a few days ago. I was then able to retrieve the mail that was delivered to the house and find this hearing notice. I have since reached out to the sellers of the house but have not heard from them. I paid the delinquent garbage bill on April 7th, 2021.

**Staff Comments**: Property owners are responsible for paying any pending assessments on property. As service was provided during Quarter 4 2020, staff recommends approving the assessment. The property owner did report making a payment for the delinquent amount to the hauler on 04/07/2021. However, as this payment was made during Quarter 2 2021, it would have been applied to the Quarter 2 2021 invoice as the Quarter 4 2020 delinquent bill had already sent to the city as an assessment.
