WHEREAS, the Business Review Council is to be made up of at least 21 and not more than 24 members, with a term length of three years and a three term limit; and

WHEREAS, CF 94-1550 requires that at least 75% of the members of the Business Review Council represent businesses; and

WHEREAS, Mayor Carter, pursuant to Chapter 3.01.8 of the City Charter, wishes to appoint Daymn Johnson, Charles Carter, Gene Gegelu, R.
