**WHEREAS,** Mr. Bode personified the Board's commitment to provide reliable, quality water and services at a reasonable cost during his tenure; and

**WHEREAS**, Mr. Bode selflessly served as the "curmudgeon in the room" for countless discussions and by doing so provided highly valuable contributions to the success of many projects; and
