**Stated Reason for Appeal (if given)**: Property owner feels that they should not have been charged an additional \$3.83. They claim that Republic Services owes them money since they were overcharged for garbage in 2021

garbage in 2021.

**Staff Comments**: Hauler records show that the property owner was credited \$69.91 on their Q1 2022 invoice. This was based on the fact that they were charging the property owner for a 96-gal cart and two 35-gal carts when the property owner only had one 96-gal cart and one 35-gal cart. This credit reduced the original invoice from \$246.43 to \$180.01. Since the property owner only paid \$176.62 on 1/24/2022, they still owed \$3.83. However, the hauler requested that the city remove this assessment as a courtesy. Therefore staff recommends removing the assessment.
