2023 maximum property tax levy for the HRA

**WHEREAS**, staff presented the 2023 HRA proposed budget to the Board of Commissioners of the Housing and Redevelopment Authority of the City of Saint Paul, Minnesota ("HRA") for its consideration; and

**WHEREAS,** the HRA Board of Commissioners, in order to comply with the State of Minnesota's Truth -In-Taxation laws, Minn. Stat. section 275.065, subd. 1, must certify a proposed maximum property tax levy payable in 2023 to Ramsey County on or before September 30, 2022; and

**WHEREAS**, the HRA proposed maximum property tax levy payable in 2023, is \$5,657,150, calculated as follows:

HRA General Fund	\$5,544,007
2.0% Delinquency Allowance	<u>113,143</u>
Proposed HRA Tax Levy	\$5,657,150

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Commissioners of the Housing and Redevelopment Authority of the City of Saint Paul, Minnesota, does hereby certify to the Ramsey County Auditor that the proposed maximum tax levy for the HRA for taxes payable in 2023 as: \$5,657,150.
