**Stated Reason for Appeal (if given)**: Property owner stated that they paid their Quarter 2 2022 invoice. However, they accidentally sent the payment to the wrong account. When they spoke to a customer service representative at Highland Sanitation, the customer service representative confirmed that the payment had been made to the wrong account and that they would apply the payment to the correct account.

**Staff Comments**: Hauler records confirm that the property owner made a payment to the wrong account and requested that staff remove the assessment. Therefore, staff recommends removing the assessment.
