Stated Reason for Appeal (if given): The title representative stated that their firm sent a Republic a check for \$173.00 in the beginning of September that was cashed. Therefore the property should not have been assessed for Quarter 3 2022.

Staff Comments: Hauler records show that the check for \$173.76 was deposited on 9/7/2022 and initially applied to a holding account as there was no indication as to where the payment should be applied. Since the hauler has been able to match the payment to the account for the property in question, they are requesting that staff remove the assessment. Therefore staff recommend removing the assessment.
