**Stated Reason for Appeal (if given):** Property owner is requesting that the assessment be reduced as they do not have the money to pay it.

**Staff Comments:** Hauler records show that the property owner did receive service for two 64-gal carts during Quarter 1 2023. Therefore, staff recommends approving the assessment. The property owner did attempt to make a payment of \$208.52 on 1/16/2023 but it was declined due to non-sufficient funds.

WHEREAS, the Office of Financial Services Real Estate Section has attached to this Council File both a report of completion outlining the costs and fees associated with Collection of Delinquent Garbage Bills for services during January to March 2023.
