- 1. A certificate of Occupancy cannot be revoked for this property. There has never been a CO issued for this property, you cannot revoke what you have never issued.
- 2. This property does not require a CO, it is owner occupied. Please see attached picture of owners ID and voter receipt from November 7th 2023 with property address and voter receipt from the precinct for 358 Arbor Street
- 3. Since the property is not a CO building the inspection is mute. However, many of the items on the inspection report are inaccruate and/or not required by code. i.d. Inspection of garage, neighbors fence, guardriail to basement, outside storage of Halloween decorations, etc.
