Approving adverse action against the Retail Food (B) - Bakery 101-1000 sq. ft. and Retail Food Grocery - Secondary Facility licenses held by Donald L. Coury, d/b/a St. Paul Flatbread Co., 439 Robert Street.

WHEREAS, adverse action was taken against the Retail Food (B) - Bakery 101-1000 sq. ft. and Retail Food Grocery - Secondary Facility licenses held by Donald L. Coury d/b/a St. Paul Flatbread Co., (License ID #20050004212) for the premises located at 439 Robert Street South in Saint Paul by Notice of Intent to Suspend Licenses dated May 25, 2011, alleging licensee failed to pay delinquent license and late fees of \$286.00 and submit a completed Certificate of Compliance Minnesota Workers' Compensation Law form; and

WHEREAS, per Saint Paul Legislative Code §310.05 (m) (2), the licensing office also recommended a \$500.00 matrix penalty for failure to submit required information in order to maintain the license; and

WHEREAS, the licensee did not respond to the Notice of Intent to Suspend Licenses to pay the delinquent license and late fees and submit required information; and

WHEREAS, the Notice of Intent to Suspend Licenses stated that if the licensee failed to pay the delinquent license and late fees and submit the required information by June 6, 2011, that the matter would be placed on the consent agenda to impose the recommended penalty; now, therefore, be it

RESOLVED, that the Retail Food (B) - Bakery 101-1000 sq. ft. and Retail Food Grocery - Secondary Facility licenses held by Donald L. Coury d/b/a St. Paul Flatbread Co., are hereby suspended for failure to pay delinquent license and late fees of \$286.00.

FURTHER RESOLVED, the licensee is ordered to pay a matrix penalty of \$500.00 for failure to submit required information in order to maintain the license. Payment of such penalty shall be made within thirty (30) days of the date of the adoption of this resolution.
