Ceiling height - Escape window - Basement - Hinding supplied a heating safety test - Basement guardrail approved last year - Entry door closes - Parking spaces - Rear garage

Yes, 4 inch variance on width of windows with dimensions of 30" in height and 16.5" in width. Hearing on the balance of the appeal.

June 21, 2011 - Grant a 3.5-inch variance on the openable height of the egress bedroom windows in the upper level, grant a variance on the ceiling height measuring 6 feet 8 inches in the upper level unit, deny a variance on the ceiling height measuring 6 feet 4 inches in the lower level unit, grant an extension for one month on the pavement issue (laid over to get aerial pictures), and grant six months for furnace testing. June 28, 2011 -Deny the appeal on the trailer issue and grant the appeal on the parking surface on condition that it is repaired.

WHEREAS, the Legislative Hearing Officer recommends that the City Council grant a 3.5-inch variance on the openable height of the egress bedroom windows in the upper level, grant a variance on the ceiling height measuring 6 feet 8 inches in the upper level unit, deny a variance on the ceiling height measuring 6 feet 4 inches in the lower level unit, grant the appeal on the parking surface on condition on the condition that it is repaired, and grant six months for furnace testing; Now, Therefore, Be It
