Premises occupied by son of owner - not rental. Son is in his 20's, occupation: photograph (low income) Remove unapproved locks on interior door - Locks are on doors on rooms unaccessible to son to ensure privacy of my personal files. No one sleeps in these rooms.

Replace guardrail & handrail - Guardrail & handrail are on only one side of the steps & guardrail is "western" style with wider slats.

My son has been in this home since he was in grade school. There are not any children in this home. This seems an unnecessary personal expense. There are many similar rails on homes built in 1983. It might be different if this was rental, but this is a direct family member, and the cost is solely mine on a home where the mortgage is greater than sale value.
