WHEREAS, the Saint Paul City Council in Council File 11-1611 accepted the Report of Completion for Emergency Boarding and Securing and/or Boarding of Vacant Buldings during the month of July 2011; and

WHEREAS, the City Council's Legislative Hearing Officer has reviewed the assessment roll, considered appeals of affected property owners and developed recommendations for City Council with respect to those assessments; and

WHEREAS, the following assessments were appealed:

<u>RLH TA 11-XXX - 636 Earl Street;</u> RLH TA 11-371 - 770 University Avenue West;

RLH TA 11-340 - 499 Western Avenue North; and

WHEREAS, the City Council held a public hearing on October 05, 2011 to consider ratification of assessment roll; and

WHEREAS, the assessment of benefits, cost and expenses for and in connection with said services, having been submitted to the Council, and the Council having considered same and found the said assessment satisfactory, Now, Therefore Be It

RESOLVED, that said assessments be and the same are hereby in all respects ratified pursuant to Saint Paul City Charter Chapter 14 and Saint Paul Administrative Code Chapter 60: Property Service Cost Assessments with the following amendments:
