Ratifying the assessments for Property Clean Up services from January 3 to 31, 2014. (File No. J1407A, Assessment No. 148517)

WHEREAS, the Saint Paul City Council in Council File RES 14-329 accepted the Report of Completion for Property Clean Up on Private Properties during the time period of January 3 to January 31, 2014; and
