Approving the City's cost of providing Collection of Delinquent Garbage Bills for service during July to September 2019, and setting date of Legislative Hearing for February 6, 2020 and City Council public hearing for March 25, 2020 to consider and levy the assessments against individual properties. WHEREAS, pursuant to Saint Paul Administrative Code Chapter 60: Property Service Cost Assessments, the Office of Financial Services Real Estate Section has prepared the attached Report of Completion of Assessment for Final Notice for Collection of Delinquent Garbage Bills for service provided July to September 2019 under Assessment No. 190162 (File No. CG1904E3); and,

WHEREAS, the Office of Financial Services Real Estate Section has prepared for the Council's consideration the attached Assessment Roll listing the benefited property, the property owner, the purpose of the assessment, and the charges as reported by the department overseeing the service; and hereby submits said Assessment Roll for the City Council's consideration to adopt and levy said charges as an assessment against the benefited property; and

WHEREAS, a legislative hearing on said assessment is scheduled on the 6th day of February 2020 at the hour of 9:00 a.m. in Room 330, Third Floor, City Hall Court House, in the City of Saint Paul; now, therefore be it
