## Legislation Text

Approving a Lease Agreement and parkland diversion for the City to lease a portion of City-owned property known as Pig's Eye Regional Park to the Board of Water Commissioners to use for soils recycling and storage.

**WHEREAS**, the City of Saint Paul ("City"), through its Department of Parks and Recreation is the owner of certain real property that is park land situated in the northwest corner of Pig's Eye Regional Park in the City of Saint Paul, County of Ramsey, State of Minnesota, (the "Property"); and

**WHEREAS**, the Board of Water Commissioners ("Board") desires to lease said Property from the City and to thereupon construct, maintain, and operate a soils recycling and storage site; and

**WHEREAS,** the City is willing to enter into a lease agreement with the Board for use of the Property consistent with the current and future requirements for the safety of City employees and property (the "Lease Agreement"); and

**WHEREAS**, the lease of said real property to the Board will constitute a diversion of park land in accordance with Section 13.01.1 of the City Charter; and

WHEREAS, the City, through its Department of Parks and Recreation has an interest in certain real property situated in the western portion of the Board's Hillcrest Reservoir property; and

WHEREAS, the Board will consider leasing the Hillcrest Reservoir property to the City to replace the park land that is being diverted; and

WHEREAS, the Board <u>has adopted a resolution authorizing the</u> <u>will</u> lease <u>at the</u> Highland Reservoir No. 1 to the City to be used as park land <u>if excess property is necessary after evaluation of the Hillcrest Reservoir location</u> in order to replace the park land that is being diverted and leave the City with no net loss of park land and satisfy the requirements of Section 13.01.1 of the City Charter; and

**WHEREAS**, the Southeast Community Organization, formerly known as District One Community Council, voted to recommend approval of said Lease Agreement at its February 1, 2021 meeting; and

**WHEREAS,** the Saint Paul Parks and Recreation Commission recommended approval of said Lease Agreement and recommended approval of said park land diversion via Resolution No. 21-02 at its February 11, 2021 meeting; and

**WHEREAS,** the Board adopted Resolution No. 21-338 at its March 9, 2021 meeting which approved said Lease Agreement and which also requested that the Honorable Council of the City of Saint Paul likewise approve said Lease Agreement; now, therefore, be it

**RESOLVED,** that the Lease Agreement and diversion of park land between the City of Saint Paul and the Board of Water Commissioners of the City of Saint Paul to lease said Property to the Board for construction, maintenance, and operation of a soils recycling and storage site is hereby approved <u>contingent upon approval of the Hillcrest Reservoir lease by both parties</u> in substantially the form submitted, and the proper officers are hereby authorized and directed to execute said Lease Agreement on behalf of the City and to divert park land
