Approving the application of Allianz Field for a sound level variance in order to present live amplified sound for the Juneteenth Celebration on June 17, 2023 outside of Allianz Field - 400 Snelling Avenue North.

WHEREAS, Chapter 293 of the Saint Paul Legislative Code was enacted to regulate the subject of noise in the City of Saint Paul; and

WHEREAS, §293.09 provides for the granting of variances from the sound level limitations contained in §293.07, upon a finding by the City Council that full compliance with Chapter 293 would constitute an unreasonable hardship on the applicant, other persons or on the community; and

WHEREAS, Minnesota United FC /Allianz Field, represented by Zacharia Litzelswope, Director, Events and Guest Experience, who has been designated as the responsible person on the application, has applied for a variance, for a requested sound level limit of 95 dBA at no specified distance, to present amplified sound on the Great and East Lawn outside of 400 Snelling Ave N. - Allianz Field; and

WHEREAS, applicant has requested a variance for the hours of 11:00 a.m. to 4:00 p.m. on June 17, 2023 with a pre-event sound check between 10:00 a.m. and 11:00 a.m. on Saturday, June 17, 2023 for the Juneteenth Celebration; and

WHEREAS, if applicant is not granted a variance applicant will not be able to present amplified sound outside of 400 Snelling Ave N. - Allianz Field; and

WHEREAS, the Department of Safety and Inspections has reviewed the application and has made recommendations regarding conditions for the variance. Now, therefore, be it

RESOLVED, that the Council of the City of Saint Paul hereby grants a variance to Minnesota United FC/ Allianz Field, subject to the following conditions:

- 1) The Variance shall be for the hours of 11:00 a.m. to 4:00 p.m. on Saturday, June 17, 2023 with pre-event sound checks between 10:00 a.m. and 11:00 a.m.
- 2) All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured at 50 feet from all sound sources.
- 3) The applicant shall provide personnel and equipment who shall provide continuous sound level monitoring at each sound source during the hours of the variance.
- 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 4:00 p.m. June 17, 2023, the event date.

FURTHER RESOLVED, that any violations of the conditions set forth above on the June 17, 2023 date may result in denial of future requests for the grant of a noise variance, in addition to any criminal citation which might issue.
