All exterior wood surfaces, other than decay-resistant woods, shall be protected from the elements and decay by paint which is not lead-based paint or by other protective covering or treatment. Service doors to accessory structures shall be provided with securing locks.

PLEASE REMOVE, REPAIR OR REPLACE THE DAMAGED GARAGE. IF YOU INTEND TO KEEP THE STRUCTURE STANDING FOR ANY LENGTH OF TIME, PLEASE INSTALL A TEMPORARY SUPPORT POST AT THE NORTHEAST CORNER OF THE GARAGE TO PREVENT COLLAPSE AND BOARD THE CORNER TO PREVENT UNAUTHORIZED ACCESS. THANK YOU.

You are hereby notified to correct these deficiencies in accordance with the appropriate codes. The Enforcement Officer will re-inspect these premises on or after **December 14, 2021**, by which date the violations noted must be corrected. **Failure to correct these deficiencies may result in the issuance of criminal charges**² and/or a civil lawsuit, and possible abatement/assessment by the City. All repairs and new installations must be made in accordance with the appropriate codes. Permits may be obtained by calling 651-266-8989.

You may file an appeal to this notice by contacting the City Clerk at 651-266-8585. Any appeal must be made in writing within 10 days of this notice. (You must submit a copy of this Notice when you appeal and pay a filing fee.)
