**Staff Comments:** PO purchased home in October 2024 and requested service hold, starting in December 2024. PO received the Quarter 1 2025 delinquent notice in May 2025 and called to originally to dispute the charges and requested removal. PO also asked multiple questions about multiple other properties, and the Q1 assessment removal was not investigated further. PO called in again in October 2025 to inquire about Quarter 2 2025 charges on other properties and asked about the Quarter 1 2025 charge and it's status. Staff then investigated issue and it was determined the Quarter 1 charges are from November 2024, which was rolled over onto the Quarter 1 billing cycle. Staff does not recommend removing the assessment.
