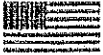

Good Morning Ms. Trousil:

Attached are the current orders for Little Saigon. They have filed for an appeal with the St. Paul Legislative Hearing officer regarding the matter. I spoke with Mr. Ward and a Neal Cooper (Mortenson Construction) and Mark Meyer (Artic Glass Co.) earlier in the year regarding the plans, permit and inspections oversight for this project as well as several others that were part of the Minneapolis Foundation Grant recipients. I was basically told the project was complete and there was no plans, permits or inspections of this work by City of St. Paul Inspection Staff.

I noted in the email trail below that Mr. Ward had directed the business owner, Mr. Nuygen to apply for a permit. I would add that Mr. Nguyen is part of an owner's group, which doesn't allow him to apply for a building permit in this situation.

St. Paul Building Department and Fire Engineering have no information on the electrical contractor for this project or the scope of the work. I am available by phone this morning until 11:00 AM.

I spoke with Si Nguyen on site this morning (operator of Little Saigon, 612-735-7953) regarding what construction services needs in regards to the sliding glass doors already installed on the interior of the boarded entrance and left a list (building, electrical and fire alarm) of those permits. He thanked me for the reminder and I corrected him that this is a revocation warning. I explained that unless there is some movement on the part of Kraus-Anderson (Brendan Ward 612-987-9224) or Mortenson (Mathew Helleen 612-251-5833) or Arctic Glass Company (Mark Meyer 763-780-8011), he will need to hire another general contractor and have them obtain permits for the already installed door system. Failing that, Fire Safety inspections personnel would be posting the revocation signage, revoking the certificate of occupancy for the building and vacating the building.

Second, Si has a contractor who will soon be installing a gate at the front of the building entrance and Si does not want to remove the OSB gate until that gate is in place. I again reiterated the need for plans and permits on this, locks, etc... for the second gate at the exterior of the glass doors entrance. He assured me they would be working on it. I explained it has been 6 months since the initial referral and no permits have been obtained. Jim Perucca asked me to put together a short synopsis regarding the property owner and grant process.

I understood from the owner and his daughter(353 University Avenue West) they had applied for and received a grant to replace the front of the building entry from the Minneapolis Foundation. Contractors (named on the page in the attached website) volunteered staff to coordinate and make the installation through subcontractors. They had contact information (phone numbers) for a couple principals at Kraus-Anderson and Mortenson and the glass company/door installation. They are all in the June 2022 Report at the website below.

Kraus-Anderson provided project manager Brandon Ward (612-987-9224) *I cannot speak to the question of permits and inspections for the projects.*

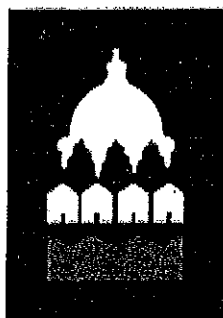

Arctic Glass (Mark Meyer: 763-780-8011) was the glass door/window installer. I spoke to Arctic Glass's Mark Meyer *(We were just a sub-(contractor) and we never get permits for work, we only do new installations and the contractor is responsible for the permits).*
