- 1) DUMPSTER/CONTAINER/VEHICLE SHALL NOT BE PLACED ON THE SIDE OF THE STREETS WHERE PERMANENT NO PARKING SIGNS ARE INSTALLED AND MUST HAVE REFLECTIVE TAPE VISIBLE FROM ALL SIDES.
  - 2) DUMPSTER SHALL NOT BE PLACED IN OR IMPEDING ANY BIKE LANES OR HANDICAPPED PARKING SPACES
  - 3) DISPLAY INSPECTION CARD ON STREET SIDE OF CONTAINER.
  - 4) PERMITEE IS RESPONSIBLE FOR PROFESSIONAL TRAFFIC and/or PEDESTRIAN CONTROL SETUP W/DEVICES & ADVANCE WARNINGS REQUIRED TO OBSTRUCT TRAFFIC LANES and/or SIDEWALKS
  - 5) 4 FT CLEAR WALKAWAY AROUND AREA
  - 6) PERMITTEE SHALL PROVIDE CONTINUOUS, ACCESSIBLE AND SAFE PEDESTRIAN WALKWAY THAT MEETS ADA AND MN MUTCD STANDARDS IF WORKING IN SIDEWALK AREA.
  - 7) CONTRACTOR SHALL PROVIDE TRAFFIC CONTROL AS PER MN MUTCD REQUIREMENTS IF WORKING IN THE ROADWAY AREA.
  - 8) CONTRACTOR SHOULD CONTACT INSPECTOR TO DISCUSS AND APPROVE PEDESTRIAN AND TRAFFIC CONTROL PLAN BEFORE STARTING WORK. ALSO, MUST ABIDE BY OSHA REQUIREMENTS TO PROVIDE A SAFE WORK ENVIRONMENT.
  - 9) USE SIDEWALK CLOSED/USE OTHER SIDE OF STREET BARRICADES & SIGNS AT CROSSWALKS & BEFORE JOB SITE-SEE MUTCD STANDARDS.
  - 10) PERMITEE SHALL DISPLAY PERMIT INSPECTION CARD IN VIEW AT WORK SITE AT ALL TIMES (LEG. CODE 135)
  - 11) PERMITEE RESPONSIBLE TO REMOVE SNOW TO CURB.
  - 12) PERMITEE RESPONSIBLE FOR SNOW REMOVAL WITHIN 24 HOURS OR AT THE DIRECTION OF THE ROW INSPECTOR.
  - 13) DISPLAY INSPECTION PLACARD IN WINDOW(S) OF ANY VEHICLES AUTHORIZED TO PARK AT THESE RED-HOODED RESERVED METERS-ORGANIZER TO MANAGE COPIES
