On behalf of Historic Saint Paul, we are writing in support of local designation of the Hamm's Brewery as a historic district. Historic Saint Paul's mission is to preserve and promote the cultural heritage, character, and vitality of Saint Paul neighborhoods. Historic Designation of this property is an important way to preserve the cultural heritage of Saint Paul and the important role that Hamm's Brewery played in the history of Saint Paul, specifically the East Side of Saint Paul.

Since the properties were vacated by Stroh Brewery in 1997, many of these buildings have remained vacant and subject to decay and deterioration. As an organization, we support the tools of historic designation to preserve and rehabilitate historic properties, especially ones as significant as these.

The State Historic Preservation Office (SHPO) and the Minnesota State Review Board recommended the Theodore Hamm Brewing Company Historic District as eligible for listing in the National Register of Historic Places (NRHP) and a NRHP nomination is currently under review by the National Park Service (NPS). Based on the historic significance documented in the NRHP nomination, we believe that the property is likely to meet the City's Criteria for Designation as a local Heritage Preservation District.

We support the ongoing efforts of the city to ensure this development comes to fruition. And we want to emphasize our support for these current efforts to designate the property as a local historic district to ensure the remaining historic brewery buildings are preserved. 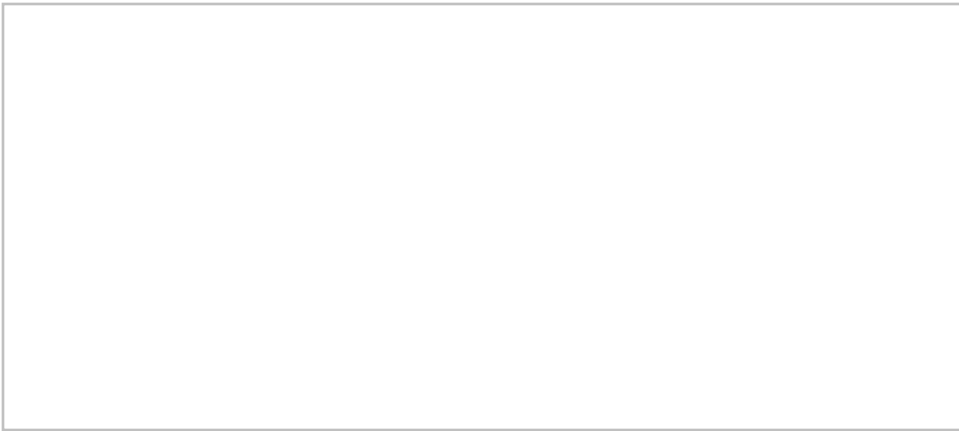
