The water hammer is tricky to record, it happens every couple hours for ~30 seconds so it's hard to catch. I'll send it along when I manage to record it. Explanation of pictures/videos 1. Kitchenette - all food is sealed, all food has been sealed since the first time a roach was spotted. Trash is taken out daily. Pests are still present in all trap locations in spite of this. 2. Windowsill - Queen Carpenter ants come out of the east wall throughout the year, with a heavy presence in spring. Combined with the previous water leak, there is a large chance of structural water damage within the walls. I am currently waiting on the City Saint Paul's Human Resources Department to email me a record of the water leak in my bathroom ceiling I filed last year, which should arrive by End of Day tomorrow. 3. Bathroom pest trap. 4. Slow drain in shower. 5. Rear lock held in by self-tapping screw. 6. Front steps are broken/disintegrating. 7. Single-pane windows which have yet to be replaced. 


