Dear Property Representative:

Saint Paul Legislative Code provides that no building shall be occupied without a Certificate of Occupancy. In order to re-occupy the building, the following deficiencies (if applicable) must be corrected, and a complete Certificate of Occupancy inspection will be required. A reinspection will be made **on June 2, 2023, at 1:00PM.**

DEFICIENCY LIST

1. Exterior - Throughout - SPLC 34.08 (4), 34.32 (2) - (4) Insect and rodent infestations. It shall be the responsibility of the owner to control and/or eliminate any infestation of insects, rodents or other pests in all exterior areas and accessory structures on the premises. **-Provide pest control: (Mice)**
2. Exterior - Throughout - SPLC 34.09 (4), 34.33 (3) -All screens shall be maintained in a professional state of maintenance and repair. **-Repair or replace the missing or torn screens.**
3. Exterior - Where indicated - SPLC 34.09(4), 34.33 (3) - Repair and maintain the door in good condition. **-Repair or remove the front and side storm doors and maintain.**
4. Exterior - Where indicated - SPLC 34.09 (4) a, 34.33 (3) a - Repair and maintain the window glass. Windows shall be fully supplied with windowpanes which are without open cracks or holes. **-Remove the wood panels and repair the broken glass on the front, side and rear porches and doors.**
5. Exterior - Throughout - SPLC 34.08 (6) - Remove the accumulation of exterior storage that creates a nuisance or harbors rodents. **-Remove materials in the front and rear porch.**

6. Interior - Basement - MN Stat. 299F.362, MSFC 1103.8 - Immediately provide and maintain a smoke alarm. **-Provide missing smoke alarm in the basement.**
7. Interior - Basement bathroom - SPLC 34.14 (3) - Provide and maintain a window or approved ventilation system in all bathrooms in accordance with building code requirements in effect at time of construction. **-Repair and provide the missing fan cover in the basement bathroom.**
8. Interior - Throughout - SPLC 34.10 (6), 34.34 (5) - Every owner of a structure shall be responsible for the control and/or elimination of insects, rodents or other pests wherever infestation exists. **-Provide pest control. (Mice)**
9. Interior - Throughout - SPLC 34.10 (1), 34.34 (4), 34.16 - Provide and maintain interior in a clean and sanitary condition. **-Clean and maintain the interior of the home. (Pet feces and mouse dropping)**
10. Interior - Basement stairs - SPLC 34.10 (7), 34.17 (5) - Repair and maintain the walls in an approved manner. **-Repair the hole in the basement stairs hallway wall.**
11. Interior - Front porch - MN Stat 299F.18 - Immediately remove and discontinue excessive accumulation of combustible materials. **-Remove the mattresses in the front porch.**
12. Interior - Throughout - MSFC 315.3 - Provide and maintain orderly storage of materials. **-Provide orderly storage in the interior of the home.**
13. Interior - Upstairs bathroom - SPLC 34.11 (1), MSBC 2902.1, SPLC 34.35 (1), MPC 301.1 - Repair or replace and maintain all parts of the plumbing system to an operational condition. **-Repair the upstairs bathroom faucet.**
14. Interior - Utility room - MSFC 604.1 - Repair or replace damaged electrical fixtures. This work may require a permit(s). Call DSI at (651) 266-8989. **-Repair the hanging light fixture in the utility room.**
15. Interior - Where indicated - MSFC 604.6 - Provide electrical cover plates to all outlets, switches and junction boxes where missing. **-Replace the broken outlet cover in the basement stairs hallway, upstairs stairs hallway, (2) missing utility room outlet covers.**
16. SPLC 39.02(c) - **Complete and sign the smoke alarm affidavit and return it to this office.**
