INSTRUCTIONS FOR FEE CALCULATION

Effective 7-31-95

GAS BURNER OR OIL BURNER

Each burner: \$42.00 for the 1st 100,000 BTU's per hour input or fraction thereof, plus \$8.00 for each additional 100,000 BTU's. Maximum fee for each individual burner shall be \$550.00. Where dual fuel installations combined permit fee shall not exceed \$1,000.00.
State surcharge is 50¢.

STEAMFITTING OR HOT WATER OR OTHER FUELS/PIPING SYSTEMS

Fee for new construction or alteration shall be one percent of the total valuation of the work. V the cost of installation, alteration, addition and repairs including heat transfer units, accessories to the pipe, fittings and all labor and materials necessary for installation. In addition, it shall include all sources when these materials are normally supplied by the contractor. Minimum fee is \$42.00.
The state surcharge is based on the valuation of the job:

\$1.00 to \$1,000.00 is a 50¢ state surcharge.
\$1,001.00 and up is .0005 times the value of the job.

INCINERATORS

Commercial and industrial incinerators are one percent of the total value of the work with a minimum installation. State surcharge is 50¢.

FACTORY BUILT FIREPLACE OR WOOD STOVE

The fee for factory built fireplaces, fireplace inserts and wood stoves for residential use shall be \$42.00. positive combustion air must be provided with the permit application.
State surcharge is 50¢.

REFRIGERATION

One percent of the total value of the work. The work must include equipment and installation.
The state surcharge is based on the valuation of the job:

\$1.00 to \$1,000.00 is a 50¢ state surcharge.
\$1,001.00 and up is .0005 times the value of the job.

TANK INSTALLATION

Fee for tank installation shall be 1% of the cost of the job with a minimum fee of \$42.00. S the valuation of the job:

\$1.00 to \$1,000.00 is a 50¢ state surcharge.
\$1,001.00 and up is .0005 times the value of the job.

TANK REMOVAL

Tank removal fee is \$100.00 per tank, per Section 33.04(A)(3).
Tank Removal has no state surcharge.

SOLAR HEATING SYSTEMS

Permit fees for solar heating systems shall be one percent of the total value as defined in Section 33.04(A)(3). fee of \$42.00. The state surcharge is based on the valuation of the job:

\$1.00 to \$1,000.00 is a 50¢ state surcharge.
\$1,001.00 and up is .0005 times the value of the job.
