## My questions:

- 1. Was the September 30, 2025 Legislative Hearing relating to 499 Snelling Avenue North the first time that matter was before the City Council? The September 30<sup>th</sup> date was the initial Legislative Hearing before the Legislative Hearing Officer, Marcia Moermond. Her role is to hear all testimonies and to develop a recommendation for City Council consideration. At that hearing, the matter was laid over to October 28<sup>th</sup> Legislative Hearing for further discussion.

At the 10/28 Legislative Hearing, no one appeared obo CVS, nor the owner of record.
- 5. Can you please send me a copy of the Code Compliance Inspection Report referenced in the October 3rd letter? There is currently no team inspection report/code compliance inspection report on file because the owner has not been applied for one.
