Please refer me to the Saint Paul Legislative Code or Minnesota State Statute that requires classic cars, screened and stored outdoors, to be licensed.

Per pages 14 (*Saint Paul Legislative Code 163.01.3.a*), 15 (*Minnesota Statute 168.10.1e*), and 22 (*Suggestions for professional correspondence*) of the correction notice response I provide at the Legislative Hearing:

Classic cars stored outdoors are specifically exempt from having tabs. Minnesota Statute 168.10.1e

states classic cars may be unlicensed and stored in any outdoor storage area screened from ordinary public view by means of a fence.

Your assistance with providing the Code or Statute that requires current tabs on stored classic cars would be greatly appreciated. Thank you.
