I received my quarter 3 bill yesterday and noticed that there was a charge for five extra bags of garbage at \$4 a piece on my bill. I know that since the city has taken over the garbage service from Gene's Disposal that I have not put out any extra bags of garbage and have been able to fit everything in the 64 gallon cart that was provided. My neighbor who lives at 620 Larpenteur does bring his cans down the alley and places them next to mine so the service truck can access them more easily, and I know they have had to put out extra bags recently. My other neighbors at 1661 Payne Ave also have extra bags of garbage frequently, but I could not state with certainty which of those two would have had extra bags out that could have been mistaken for mine. I just don't want to be charged for a service that I did not use and would appreciate if someone could reach out so we could resolve this issue.
