If you would like a license condition added or changed, we can register this as a letter of objection/concern, which would trigger a license hearing where that could be discussed.

Good morning,

I am reaching out as a resident of 42 Saint Albans Street South, which is immediately across from 685 Grand. We received the license application notifications. While we have no problem with Razava Bread Company being granted a liquor license, we are concerned with the proposed times of business if the licensee is authorized to provide liquor service in the right of way.

This street is entirely residential. We are extremely concerned with the increased noise after 10:00 p.m. if the licensee is allowed to serve liquor until 12:00 a.m. outdoors 7 days a week. WE strongly object to outdoor liquor service daily until 12:30 a.m.

If the liquor license is granted for the public right-of-way, we would

request that liquor service outdoors end at 10:00 p.m., which is when quiet hours start in Saint Paul.
