DSI received a voicemail objecting to the Health/Sports Club license application at 431 Snelling Ave N. In speaking to the caller, she only just read the letter today and lacks a working computer to submit her objections via email. I spoke to her and she requested I took down her concerns for the record.

Dorothy Irvin , a resident at 1615 Saint Anthony Ave, has concerns relating to the proposed business and apartments in very close proximity to the business. Approximately a year ago she and others in the neighborhood received a letter from the city notifying them that four men with a history of sexual child abuse crimes would be living in the 400 Block of Roy St N.

She has concerns that the men may be associated with the business; either as partners, employees, or customers, and may use the health/sports club facility to continue to commit sexual crimes with minors.

She ended the phone call stating that Saint Paul has had a history of protecting minor victims of sexual abuse, and that she hopes the city continue this work. Her number is 612-387-3784.
