Re: Remove or Repair of the Structure at 939 Charles Avenue

Dear Ms. Miller:

This is to confirm that at the Legislative Hearing on Tuesday, September 24, 2024 Legislative Hearing Officer Marcia Moermond will recommend that at **the October 16, 2024 Council Public Hearing that if the Code Compliance certificate isn't issued by October 16 and nuisance abated, they:**

- forfeit \$2,500 of your Performance Deposit and continue the Council Public Hearing to November 6, 2024.
- If still not completed, forfeit additional \$2,500 and continue to November 20, and;
- continue in that fashion with 2-week layover until project is complete and nuisance is abated and/or Performance Deposit is entirely forfeit.

This matter will go before the City Council again at Council Public Hearing on **Wednesday, October 16, 2024 at 3:30 pm. in room 300 City Hall.** If you are contesting Ms. Moermond's recommendation, or have not received your Code Compliance certificate, you may:

1. appear in person (*please arrive before 3:30 p.m. and check in with staff outside Council chambers*); or
2. **Should you wish to testify remotely (and not appear in person), you must register by noon on Tuesday, October 15, 2024 to testify via phone here:**

Please note the Council Public Hearing layover dates above as well; the Council Public Hearing would be at 3:30 pm on each of those dates with a noon deadline the day before for signing up to testify by phone. If you don't wish to contest then **no further action is needed** and the Council will proceed with Ms. Moermond's recommendation above.
