### Narrative :

I, Officer M.Semelis (Squad #457), am a Mental Health Officer with the St. Paul Police Department Community Outreach and Stabilization (COAST) Unit. In this assignment, I serve as a liaison between the Department and mental health resources as well as coordinate activities within the unit. I also attempt to connect community members in need with available resources.

I was assigned to review this case for possible follow-up and referral. I began by reviewing all included reports and information for the parties involved, to determine the best course of action. The Officers on scene did not locate any evidence or information that would indicate a crime had been committed.

In this incident Officers spoke to Colleen Mulcahy (DOB/1970-07-19) who reportedly believes she is being harassed by previous roommates. Mulcahy was left on site.

In researching the subject's name, I found no additional COAST Mental Health related police contacts within the last twelve months. I also found prior civil commitments for mental illness and chemical dependency, with the most recent ending on 02/06/2023 in Ramsey County.

In searching the Minnesota BCA public criminal history database, I found that Mulcahy has misdemeanor prior convictions.

I spoke with one of our embedded social workers who advised they will either follow-up with this individual or, if applicable, notify existing service providers. At this time, the case will be NOTED.
