Scope of the Cryptocurrency Fraud Problem

- In 2023, Americans reported losing over \$5.6 billion to cryptocurrency scams, a 45% increase from 2022. The FBI's [Internet Crime Complaint Center](#) (IC3) reported a 53% increase in losses from cryptocurrency-related investment fraud schemes, from \$2.57 billion in 2022 to \$3.96 billion in 2023. Scammers are increasingly targeting seniors with intimidation tactics and manipulations, often using cryptocurrency ATMs.
- According to the Federal Bureau of Investigation, cryptocurrency ATM schemes have increased, particularly among older adults. Of the more than 5,500 complaints involving cryptocurrency kiosks reported to the agency's Internet Crime Complaint Center in 2023 (the latest data available), almost half came from people over 60. Of the roughly \$189 million of losses involved in the complaints, \$124 million belonged to those over 60
- In 2023, consumers in Minnesota reported losing \$125.6 million to fraud, according to Federal Trade Commission data. Nationally, the FTC says, Americans lost more than \$10 billion that year; due to underreporting, that figure is likely far higher.

How Crypto ATM Scams Work

- Several factors make crypto attractive to scammers: There's no bank or other centralized authority to flag suspicious transactions, crypto transfers can't be reversed, and most people are still unfamiliar with how crypto works, according to the FTC.
- Cryptocurrency ATM/Kiosks, are used for legitimate purposes to convert dollars into digital currency. But criminals also rely on them as a fast, easy and often untraceable way to get access to victims' cash. Often used in tech support, extortion or government impersonator scams, a criminal will instruct their victim to withdraw cash from their own bank and deposit it into a crypto ATM/Kiosk to buy virtual currency. The virtual currency is then sent to the scammer's digital wallet, usually irreversibly.
- With cryptocurrency ATM/Kiosks there's "a large level of confusion" because people aren't familiar with them. "When the scammer gets them on the phone, keeps them on the phone, directs them to go obtain cash from the bank ... they're just in the mold where they're just following directions,"

Measures Being Adopted to Stop Crypto ATM Fraud

- Transaction limits for new users
- Live verbal confirmation for larger transactions,
- Full refunds for fraudulent transactions reported within a certain timeframe
- Operator requirements like registration, disclosure of ATM locations, and provision of receipts with transaction details.
- State and federal legislatures are also pushing for these and other preventative measures on the operator side.
- Disclose to consumers relevant terms and conditions.

New Minnesota crypto law goes into effect to protect consumers against fraud

A new Minnesota law goes into effect on August 1, 2024, to protect consumers against cryptocurrency fraud. The Minnesota Department of Commerce Financial Institutions and Enforcement Divisions are taking action to ensure crypto companies are licensed to operate in Minnesota and comply with the new consumer protection law.

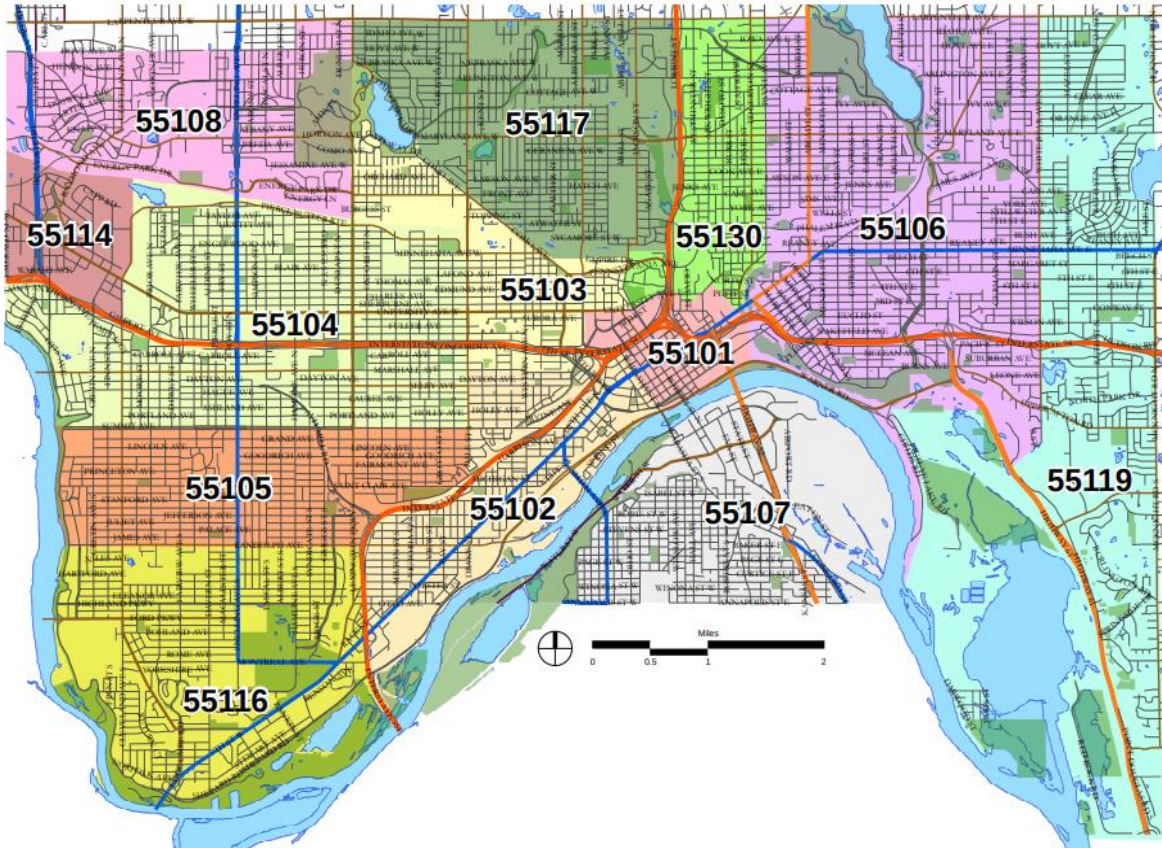
Consumers are using crypto kiosks, which work similar to cash ATMs, with increasing frequency. Unfortunately, crypto kiosk users are increasingly also becoming victims of scams. During the 2024 Legislative Session, Commerce worked with the bill's chief authors Rep. Amanda Hemmingsen-Jaeger and Sen. Jen McEwen, as well as with local law enforcement and other stakeholders, to develop this critical consumer protection bill.

The law applies to licensed crypto kiosk operators, requiring them to:

- Disclose to consumers relevant terms and conditions.
- Issue refunds for those involved in fraud if they are a new customer.
- Set a maximum daily transaction limit of \$2,000 for new customers.

“Unfortunately, crypto scams are becoming more common, and scammers used crypto kiosks to steal money from consumers. This new law works to protect Minnesotans from scams and to recover funds consumers lost to fraud,” said Commerce Commissioner Grace Arnold.

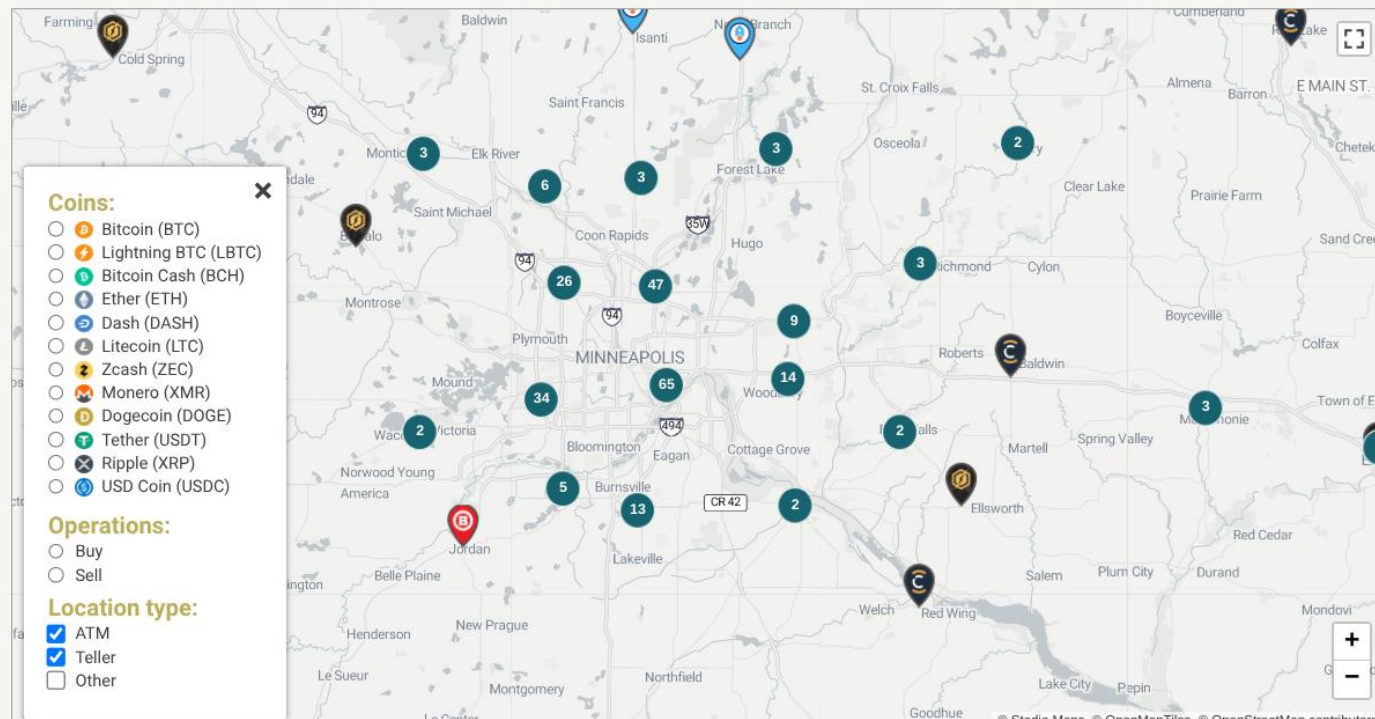
St Paul, MN Zip Code Map

What is a Cryptocurrency Kiosk/ATM

- Kiosks are similar to your traditional ATM but focus only on cryptocurrency-related transactions. Many cryptocurrency kiosks exist in gas stations, check cashing establishments, and grocery stores.
- You can use a kiosk in the same way you use your cryptocurrency wallet on a cryptocurrency-related app.
- Minnesotans may be lured by scammers to use a kiosk to transfer money to a wallet as a way for the scammers to steal their money and disappear without a trace. Often, these requests to transfer money are urgent in nature in an attempt to prompt the person to act quickly.
- Kiosk operators are also required to have a money transmission license.

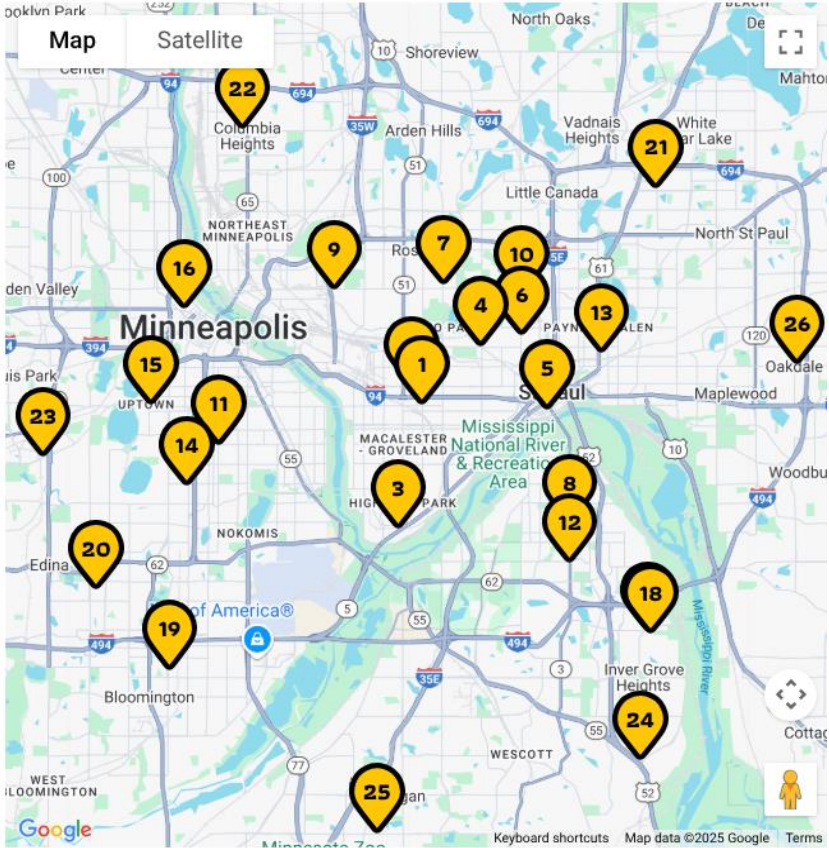
