Hello,

I am looking to appeal and to understand what is the correct amount of vehicles permitted to park in the driveway lot for property located on 879 Thomas Ave, Saint Paul, MN, 55104.

I have called and have talked with the City Inspector, and he said that the second vehicle is in violation, and that the driveway is permitted for only one vehicle.

Because of that, I am here to appeal that it is not a one vehicle driveway lot, and that the second vehicle should not be in violation.

Here are some of the testimonies and evidences for the appeal:

1. The property is a duplex.
2. The property has a two car lot.
3. Residents/Tenants that have lived on the property have been able to park two cars in previous years without issue.
4. Throughout parts of the same neighborhood, other people are also parking in similar situations or parking in smaller lots with smaller side yard parking.
5. I am not sure if this Legislative Code also applies to the property, but I thought I would mention it here.

Zoning code allows for some limited space parking. Per. Chapter 66. (18) *Parking location and design.*

- a. Off-street parking shall be provided within a principal structure, underground, or to the rear of buildings to the greatest extent possible. Limited side yard parking may be appropriate.
