<p><b>Synopsis :</b></p> <p>On 05/05/2024, a vehicle appeared to be racing with another vehicle on Maryland Ave and Frank St. The vehicle then spun out, struck a stop sign and then struck the house. The driver of the vehicle, reversed and fled southbound on Frank St.</p> <p><b>Narrative :</b></p> <p>On 05/05/2024 around 1825 hours, I, C. Xiong (Squad 384), responded to Maryland Ave E and Frank St. for an accident hit and run.</p> <p>There were multiple callers on the accident. Call comments stated a vehicle described as a maroon Suburban with Minnesota license plate ran into a house. The vehicle then fled southbound in a high rate of speed. The owner of the residence also called stating a vehicle hit her home and fled. The owner stated the vehicle left a plate behind of MN LIC NWH204. Another caller stated the vehicle was leaking fluids.</p> <p>Upon arrival, I observed Transit PD Officers on scene. I observed multiple individuals standing by the accident scene. Transit PD Officers informed me people on the scene advised them that the driver of the striking vehicle was a White male. They informed me that the vehicle fled southbound on Frank St.</p> <p>I observed damages to the north end foundation of the residence located on 1122 Maryland Ave. I observed the southeast corner stop sign laying on the ground near where it was posted. There were tire marks from the street leading to the northwest corner of the house. A maroon colored front bumper was near the tree on the property with MN LIC NWH204 which registers to a 2003 Maroon GMC YUKON XL LIC/NWH204 SPORT UTILITY VEHICLE. I did not observe any injuries nor were any injuries reported.</p> <p>St. Paul Fire (run#21297) arrived on scene to assessed the house.</p>

Squad 181 (Needham/Reschke) responded to 688 Minnehaha Ave W where the vehicle registers to. Squad 181 did not locate the vehicle, however, they obtained a phone number for the registered owner identified as DOMINIC DAVANTE GRILLO (DOB/1993-07-25). Per Squad 181, DOMINIC stated he is at a football practice for his son in Cottage Grove. DOMINIC believes his brother who was at the address earlier may have taken the vehicle.

I called DOMINIC. I informed him about the accident. DOMINIC was crying and upset. He said he is not home and did not know that his vehicle is involved in the accident until he spoke to officers. I assured DOMINIC that no one was injured. I asked DOMINIC about his brother. DOMINIC said his brother who he called "JESSE" (unknown spelling) spoke with him telling him that he was going to go to jail. He confirmed that his brother was driving the vehicle. However, DOMINIC was not willing to give me any more information about JESSE. I asked DOMINIC if JESSE is injured. DOMINIC said JESSE is not.

I asked DOMINIC if he has auto insurance and DOMINIC stated yes. He sent me a screenshot of the auto insurance for his vehicle with the vehicle's vin number displayed on it (American Family Insurance #410053514651). The effective date is 12/17/2023 and expires on 06/17/2024. The screenshot was uploaded to the media vault.

I called the initial complainant identified as TANYA CASAVANT (C/P#651-231-8864) and I asked her if she witnessed the crash. TANYA stated her boyfriend identified as ROBERT KEITH GORDON (DOB/1988-01-20) witnessed the crash.

ROBERT informed me that they were traveling westbound on Maryland Ave when he saw the maroon Yukon and a black SUV were traveling eastbound on Maryland Ave towards Phalen Blvd. about 50-60 miles per hour. He said both vehicles appeared to be racing each other. ROBERT said he thinks the maroon Yukon was trying to pass the black SUV because the maroon Yukon went onto the westbound traveling lane of Maryland Ave into oncoming traffic. ROBERT said the vehicle lost control, spun multiple times, struck the stop sign and then struck the house. ROBERT said the crash was so loud, he thought the vehicle was going to explode.

ROBERT said they turned around thinking the driver of the maroon Yukon needed medical attention; however, ROBERT said he saw the driver reversed the vehicle and then flee southbound on Frank St in a high rate of speed. ROBERT said he followed the vehicle and saw the vehicle continued southbound on Earl St. over the bridge.

I took photos of the scene which were later uploaded to the media vault.

Squad 377 (C. Dean) spoke to the house owner identified as ANGELA MAKEBA MYERS (DOB/1971-06-14). MYERS informed officer C. Dean that she has homeowner insurance. She was given the case number for this incident.

St. Paul Public Works were notified about the disabled stop sign. While on scene, they arrived and replaced the stop sign.

It should be noted, I looked up 688 Minnehaha Ave W on DVS. I found a JESSE JAMES ANDERSON-SPEARS (DOB/1998-10-19) who has the address as his registered address on his
