PUBLIC HEARING

- 4 [PH 24-5](#) Commercial Corridors Fund Public Hearing

Chair Noecker thanked the members of the public that were present and gave a presentation on why a new fund, eligibility, and proposed application process.

Commissioner Jalali is interested in making the eligibility requirements more flexible, and would like to hear what challenges the community partners have identified. Chair Noecker explained that the proposed funding for this program is an existing funding source. This is an Economic Development STAR fund that doesn't carry the same capital requirements, making this fund more flexible than Neighborhood STAR. The existing Neighborhood STAR and Year Round STAR programs will remain the same. There will be no Board to go through with this application process.

Commissioner Bowie recommended having allocated flexible and small scale funds for the marketing and promotional materials separate from building and acquisition funding.

Commissioner Yang asked if this funding would be a reimbursement based program. Chair Noecker stated that this still needs to be determined and that she would prefer it not be a reimbursement program but that the funds would be allocated. The hope is that the program is easy to use and less cumbersome on staff. Commissioner Yang echoed the desire for an allocation rather than a reimbursement and stated that it would most likely get more people to apply.

Chair Noecker explained that this fund is a pool of STAR dollars that are over and above what is needed to put into Neighborhood STAR and Cultural STAR and the RiverCentre each year. These Economic Development STAR dollars can be used for anything that increases tax base or revenue for the City including non-capital expenses.

Commissioner Johnson, co-sponsor of this program, stated that she is excited to hear the public comment and testimony on this program, and explained that this is hopefully an opportunity for the public to easily access these dollars. She appreciates all the feedback from staff.

Commissioner Kim is grateful for this program and how it's emphasis is on how the City is investing in cultural corridors and commercial corridors across the city because some neighborhoods do not have business support organizations that operate at the same level of sophistication as others or that even exist.

Executive Director, Nicolle Goodman clarified that the intention is that the funding would go to the business support organization and not individual businesses and that there would be a contract with that organization that would require quarterly reporting. We would need to have record keeping but it may be significantly streamlined.

Testimony in favor of the program was heard from former Director of two community development corporations, Anne DeJoy, 2257 Maryland Avenue, E; and Kim O'Brien, resident of Ward 7, Executive Director of the Rice and Larpenteur Alliance, and Executive Director of the Grand Avenue Business Association.

Motion to close the public hearing by Commissioner Jalali. The public hearing was closed.

Commissioner Yang further commented that the public comments have offered a lot of great input for staff to start with. She continued with a conversation she'd had about construction and the impact it has on businesses, for example, MNDOT is going to do construction on Arcade Street next year and there isn't any aid being provided to the businesses. The Payne Phalen District Council has expressed concern about this as well and Commissioner Yang feels it is really important that we explore whether rent or low interest loans could be an eligible expense for this fund.

Chair Noecker concluded by thanking everyone that was present, and stated that they have a lot of comments and suggestions to work with and that Vice Chair Johnson, Executive Director Goodman and herself will come back with a full proposal to be included with the HRA budget proposal.

Inspiring Communities - Small-Scale Development Strategy Update

Executive Director Goodman introduced Principle Project Manager, Joe Musolf, and stated that Mr. Musolf would be giving an update on what's been called the Inspiring Communities as a single family program, but is now pivoting the focus to Small-Scale Development with the up-zoning and added density.

Joe Musolf gave a presentation and answered questions from the Board.

Chair Noecker recommended Mr. Musolf schedule individual meetings with the Board members once the details are written up into a proposal, and return to the HRA Board with a final guidelines proposal and program discussion.

Ms. Goodman clarified that the pivot does not require any guideline changes; the disposition policy is already in place and there isn't anything to bring back to the Board.

Chair Noecker requested that the item return with more detail on how the process, already in place, would work.
