Synopsis :

Police responded to the 1600 block of White Bear Ave for a report of a burglary. The entrance door to Grand Cleaners was damaged and found unsecure. A neighbor reported seeing unidentified suspects successfully prying the door open with a running parked car nearby.

Narrative :

On 3-7-2024 at approximately 0600 hours, Officer Sandell and I (310T) responded to 1645 White Bear Avenue. The call notes stated that there was 2 unknown individuals who appeared to be attempting to pry open a door to a locked business.

Upon arrival, we were met by a Zietlow, Julie who stated she was the one who called. Zietlow told us that she saw a white or a silver vehicle that she describe as Cadillac parked outside of Grand Cleaners within the last hour. Zietlow said that 2 unidentified suspects appeared to pry a door open with a crow bar. I was able to see the door in question and noted the glass door on the North side of the building was unsecured and had damage to the lock. Photos of the damage were taken on my issued work cellphone and were uploaded to Axon Capture.

Zietlow also informed us that she had Ring doorbell footage. We were able to see a white or silver sedan as well as two unknown suspects near the entry point. I gave Zietlow my business card with my email so she could send me a copy of the incident. She told me she would send it later today. It will be uploaded to the media vault when received.

Officer Sandell and I then performed a sweep of the building. No one was found.

We attempted to secure the building but were unable to. We were not also not able to find any owner of this establishment. We are at this time unaware of what was taken and it's value. I left my business card with a case number on the door.

A board up was ordered for the entrance door.

Narrative :

I, Sergeant Isaac (Ike) Palmer, am assigned to Eastern District Investigations for the St. Paul Police Department and was assigned this case for review and investigation. I began by reviewing all the included reports and information, as well as any pictures if applicable. The reports on all parties involved were reviewed to determine the course of investigation, as well as the level and probability of solvability. This is all done for information gathering purposes, as well as possible future criminal charges.

On 03.11.24, I, Sgt. Palmer, observed that the possible keyholder had a possible phone number of 651.200.3188. I spoke to a male who stated that the laundry business did not have any damage. He was unaware of another door to a business or possibly an empty space on the back of the building. He recalled seeing a locksmith at the building, but it was not for the laundry business.

I checked St. Paul records and observed the owner was Mars 1 LLC (500 84th Cir NW, Coon Rapids, MN). The address, per Google, appeared to be a residential home.

I was able to speak to Muntasir EISA (02.18.82; 500 84th Cir NW, Coon Rapids; C-612.406.0405). EISA owns the building. There is no business occupying the area where the burglary took place. It is currently vacant, and he has some construction work completed.

The business "The Laundry Room" is also at 1645 White Bear Ave and may have security cameras that captured the incident, but EISA was unsure. EISA believes whoever broke into his building stole tools belonging to the people doing construction. One construction worker was believed to be Rick (651.274.8736), and the other was Jason.

On 3/12/2024 I received a video evidence collection request from SGT. ISAAC PALMER. The request was to collect video pertinent to this incident from The Laundry Room, located at 1645 White Bear Avenue St. Paul, MN 55106.

I went to the location and met with the owner, SAM 651-200-3188, and asked him about is security cameras around the building. I told SAM I was looking to obtain video related to this incident. SAM told me that the cameras do not record. SAM said the recording device does not have a hard drive installed to store the video. He is only able to watch live video, but nothing further.

I then went to Walgreens, located at 1665 White Bear Avenue St. Paul, MN 55106. This Walgreens is located just North of The Laundry Room. I spoke the the manager, ISHMAIL 651-251-1933, and asked him about cameras that face The Laundry Room. ISHMAIL said they do not have any
