- 1. Ecolab is fee owner of certain real property situated in the City, commonly known as Ecolab Global Headquarters and legally described in <u>Exhibit A</u> (the "<u>Ecolab Global Headquarters</u>").
- 2. City operates and owns certain real property situated in the City, commonly known as Hamm Plaza and legally described in <u>Exhibit B</u> (the "<u>Plaza Property</u>").
- 3. Ecolab and City have executed a Plaza License, Operations and Maintenance Agreement dated August 2, 2023 (the "<u>License Agreement</u>") for the benefit of the Ecolab Global Headquarters and the Plaza Property.
- 4. Pursuant to the License Agreement, Ecolab and the City have certain rights and obligations related to the Plaza Property, as more particularly set forth in the License Agreement.
- 5. All of the terms, conditions, provisions, and covenants of the License Agreement are incorporated into this Memorandum by reference as though fully set forth herein, and the License Agreement and this Memorandum shall be deemed to constitute a single instrument or document.
- 6. This Memorandum has been entered into by Ecolab and the City for purposes of recordation in the real property records of Ramsey County, Minnesota to provide notice to third parties of the License Agreement and nothing contained herein shall be deemed or construed to alter or amend the terms of the License Agreement. In the event of a conflict between this Memorandum and the License Agreement, the License Agreement shall control.
- 7. The terms and conditions of the License Agreement and this Memorandum are binding upon, and shall inure to the benefit of Ecolab and the City and their respective successors and assigns.
