

To provide some history, the business is called Zen Room Kava Lounge, and serves bottled beverages, coffee/tea and pre-packed light snacks (no food processing on site per the tenant). This is their website <u>Home</u>. Prior to this new business, it was a chocolate shop.

The current approved use for the commercial space is listed under Mercantile, and the space is approximately 825 square feet. The tenant states MDH inspected the business and no license was required. I am trying to confirm this information.
