


















Disposition process options





Disposal of HRA property

- Request for Proposals (RFP):
 - The HRA may solicit proposals for a specific site through a RFP process.
 - The RFP is advertised through multiple sources (online, newspapers, on the site via signage, notice to District Council, etc.).
- Other Proposals:
 - The HRA may receive a proposal from a third party to redevelop a parcel of land.
 - HRA staff reviews proposals and may present the proposal to the HRA Board for consideration, if it meets certain criteria:
 - Consistency of reuse with plans (zoning, historic guidelines, etc.), development costs, time to complete, contributes to tax base, experience and qualifications of developer, etc.
 - A proposal recommended for HRA consideration is presented to the HRA Board, and the District Council is given notice 45 days before HRA consideration.




