This is to confirm that at the Legislative Hearing on May 9, 2023, Legislative Hearing Officer Marcia Moermond recommended that the City Council **grant an extension to May 17, 2023 for compliance**. Please note that this is different than the date discussed in your Legislative Hearing.

This matter will go before the City Council at Public Hearing on **Wednesday, May 17, 2023 at 3:30 pm. in room 300 City Hall**. If you are contesting Ms. Moermond's recommendation from the April 25 hearing you may:

- appear in person (please arrive before 3:30 p.m. and check in with staff outside Council chambers)

If you don't wish to contest, no further action is needed and the Council will proceed with Ms. Moermond's recommendation above.

After the May 17 Public Hearing, Ms. Moermond will review this case under a new resolution at a May 22 Legislative Hearing at 11:00 a.m. to determine if you have abated the nuisance(s) listed above on deadline. The City Council Public Hearing for that will be scheduled for Wednesday, May 24 at 3:30 pm. in room 300 City Hall. You are welcome to attend any of these hearings. If you are contesting Ms. Moermond's recommendation from the May 17 hearing, you may appear in person or send written testimony to be added to the record to
