## Staff Comments

This PO reports they have been billed for two 35 gallon carts at their duplex since April 2025 but there has only been one 35 gallon cart at the property. Property is now enrolled in Cart Sharing. The property was also charged for five extra bags, and the hauler stated we can remove one bag charge from the November 13 collection. Staff recommends reducing assessment to \$104.33, for one 35 gallon weekly cart, one 35 gallon every other week cart, and four extra bags

Hi Dan

Thank you for reaching out about your Quarter 4 2025 garbage bill. In order to get the bill adjusted, I have to take it to a legislative hearing on Thursday, May 28. Because the property is a legal duplex, all units were required to have a garbage cart at the property for all of 2025, therefore I will recommend reducing the garbage invoice for Quarter 4 2025 from \$192.93 to \$168.31. Here is the breakdown:

\$82.69 - 35 gallon cart with weekly collection

\$58.47 - 35 gallon cart with every other week collection

\$27.55 - Five extra garbage bags collected on Nov 6, Nov 13, and Dec 11 (I have opened a separate ticket for this one so I can request photos)

If you agree with my recommendation, you are not required to attend. If you disagree, you will need to attend by phone. We will call you around 9:30am if you choose to attend.

As for the previous quarters, we are unable to dispute them, as the time to dispute the invoices has passed. We have been mailing the invoices to the taxpayer address on file with Ramsey County, and then have not been returned to us.
