Hello Paul,

This is follow-up to your conversation with our office last week about garbage service at 2129 Reaney Ave. I understand that you don't have a garbage cart because it was removed by the old hauler when the new garbage program launched on April 1. I see that you have 2 outstanding bills - one for Quarter 2 (April-Jun) and the other for Quarter 3 (Jul-Sep). Since you didn't have a cart, we can remove the charges for Quarter 3; however, unpaid Quarter 2 bills have already gone to hearing to be assessed to property taxes. I will have our billing specialist reach out to you about how to handle the Quarter 2 billing.

As a single-family dwelling in Saint Paul, you are required to utilize City garbage service, so we need to get you a cart and start service again for you. Please let us know what size cart you would like delivered. If we do not hear from you by Friday, November 21, we will deliver a medium, 64-gal cart to your property.
