Dear Mr. Grimm:

Legislative Hearings were conducted in the above-referenced matter before Marcia Moermond, Legislative Hearing Officer, and she recommended that the City Council grant an additional 180 days for the nuisance building to be abated by razing and removal or rehabilitation, as evidenced by issuance of a Certificate of Code Compliance.

There will be a Legislative Hearing scheduled for Tuesday, September 24, 2024 at 10:00 a.m. in Room 330 City Hall at which DSI staff will present information on the current building conditions and progress toward abatement of the nuisance conditions. If you will not be able to attend in person, let me know and I call you into the hearing via telephone between 10:00 and noon.

If you received the Certificate of Code Compliance by September 24, 2024, this hearing will be cancelled and a resolution will be forwarded to the City Council indicating the nuisance conditions have been abated and the matter is closed.

If you have *not* received the Certificate of Code Compliance by September 24, 2024, **please contact Building Inspector Clint Zane at 651-266-9029 as soon as possible for a progress inspection** before the hearing. For other vacant building related questions, contact Joe Yannarelly at 651-266-1920.

The findings of the Legislative Hearing will be considered at a City Council Public Hearing on Wednesday, October 16, 2024, 2023 at 3:30 p.m. in Room 300 Council Chambers.
