of herself and live alone and was not living there a lot of the time.

She had stated that there were many problems with the trash service, not picking up her trash, so I know there were many times that she would bring bags of garbage over and dumped them in my apartment complex trash. Trash and recycling are done separately. I don't know what she ever did with the recycling, but I know trash seemed to be a problem for her for quite some time.

Nobody is living in the house now we have been trying to get it cleaned out and fixed to sell. Any trash that has come out of the house has not been left out on the curb. We have been taking it to the dump and paying to have our trash removed. If the trash service can be stopped now or put on pause until we sell the house that would be fabulous cause I don't anticipate using your service until the house gets sold.

As for the water, I don't know if water is assessed on usage, but again she wasn't in the house much. I do need the water to clean so I hope that's not going to be turned off and I am not sure what to do about the old past bills for that.
