Think Before You Click: This email originated **outside** our organization.

I looked at this proposal and would request several amendments if this very large building is going to be built in an area with very little street parking available.

The "affordable" housing must be truly affordable housing, which means real poor people can live here and it's not based on a meager percentage of the "median neighborhood income."

The people accessing the affordable housing **must be given free** parking BEFORE people with money.

This area is well known for not having enough street parking which is amplified in the winter when there is a lot of snow and during snow emergencies. The builders must provide at least one parking place per unit.

In addition to adding parking they **must dig for their parking, no variance on the height is acceptable**. It will already block the light for the houses in the immediate area. Loss of light will negatively affect the property values in the area. It will also negatively affect current residents because of the shade these tall buildings create. There will be a loss of natural current existing habitat, and risks to mental health (darkness) for residents in the immediate vicinity of this project.

If they cannot meet these provisions above, I recommend you reject the variances.
