Emmett Owens, Jr.:

This is to confirm that at the Legislative Hearing on October 21, 2025 Legislative Hearing Officer Marcia Moermond recommended that the City Council grant to **January 1, 2026 for compliance with items related to weight lifting and punching bag(s), and grant to November 24, 2025 for balance of the orders; also grant to November 24, 2025 for compliance with the Vehicle Abatement Order.**

This matter will go before the City Council at Public Hearing on **Wednesday, November 12, 2025 at 3:30 pm. in room 300 City Hall.** If you are contesting Ms. Moermond's recommendation you may:

1. appear in person (*please arrive before 3:30 p.m. and check in with staff outside Council chambers when you arrive*).

If you don't wish to contest then **no further action is needed** and the Council will proceed with Ms. Moermond's recommendation above without discussion.

As mentioned in the hearing, you get 1 bulky item per month removed for free (for each unit/house; so theoretically each property you own you could do one/month).

How to Schedule bulky item collection:

Contact the City at least two business days in advance of your garbage collection day to request a pickup. Please call 651-266-6101.

How Many Items Can I Have Collected?

Starting April 2025: All households with one to four units are allowed one bulky item pick-up per unit, per calendar month with regular garbage service. These pickups are included in the cost of your regular collection.

You may only have three total appliances and/or electronics picked up per unit annually.



Additional Bulky Items: If you need to dispose of additional items during the same month, you can pay \$30 per bulky item (plus tax) to have them collected.

Ms. Moermond will review this case under new resolutions at a November 25, 2025 & January 6, 2026 Legislative Hearings at 11:00 a.m. to determine if you have abated the nuisance(s) listed above on deadline. The City Council Public Hearings will be scheduled for Wednesday, December 3, 2025 and Wednesday January 14, 2026 at 3:30 pm. in room 300 City Hall. You are welcome to attend any of these hearings. If you are contesting Ms. Moermond's recommendation from the November 25 and January 6 hearings, you may appear in person. If you have any questions, please contact our office at 651-266-8585.
