### MISCELLANEOUS CODE VIOLATION REPAIRS

1 - Furnish & install a code compliant gas valve for the range and cap any piping as needed.	
2 - Furnish & install a code compliant gas valve for the dryer.	
3 - Furnish & install insulation on the dryer vent.	
4 - Furnish & install a 1" cold water main from the water meter to the tee that feeds the water heater. Replace the street side meter valve with a 1" code compliant shut-off valve.	
5 - Replace the flue piping from the water heater to increased 4" piping.	
6 - Furnish & install a new laundry faucet for the cement sink. Replace the hot & cold bibs for the hook up of the washing machine.	
7 - Replace the kitchen sink drain piping with 2" code compliant piping. Replace from vertical 2" piping in the basement to the waste tee in the cabinet.	
8 - Cut out the tee feeding the abandoned humidifier valve.	
9 - Acquire city permits & coordinate city inspections.
