It has come to her attention that there was no representative on-site for the scheduled Team/Code Compliance inspection so it was unable to be conducted. The Legislative Hearing Officer is concerned because there was a request from her to expedite that inspection.

Additionally, Vacant Building staff indicate that there continues to be graffiti on the building that remains unaddressed. Additionally, please ensure sidewalks are maintained adequately—this means cleared full width and salt and sanded as needed.
